## ABOUT THE DATA AND POLICY ANALYST ROLE

The Policy and Data Analyst is responsible for the execution of Breakthrough's policy advocacy activities and the analysis of data to improve the organization's services. Reporting to the Chief Program Strategy Officer and working closely with the Executive Director, the Policy and Data Analyst plays a critical role in the organization's ability to leverage the data and the experiences of our students and families to drive change within the organization and the broader Central Texas education system. The Policy and Data Analyst, under the supervision of the Chief Program Strategy Officer, ensures that our data collection and analysis is aligned with our program goals, yields meaningful insights to drive our work, and is informed by the experiences of Breakthrough participants and external research. In addition, the Policy and Data Analyst will work closely with the Executive Director to develop a policy agenda, engage with potential advocacy partners, and execute the organization's annual policy advocacy activities. To accomplish these goals, the Policy and Data Analyst will:

- Maintain ongoing data collection system
- Manage, analyze, and interpret Breakthrough student data
- Create and share reports and analyses internally and externally
- Ask questions to help others make sense of the data
- Interpret trends and patterns in complex data sets

- Collaborate with Breakthrough program staff to ensure data collection and analysis is closely aligned to program objectives
- Create and maintain protocols for data integrity and security
- Help maintain our salesforce database
- Refine our data collection calendar, working in concert with our program staff and our partner school districts
- Collect and analyze research external to the organization pertinent to the field of education and postsecondary access and completion
- Help create and maintain the guiding statement for Breakthrough's policy work
- Engage in research to build the organization's knowledge of the policy field
- Help develop a process and criteria for determining Breakthrough's annual policy agenda
- Engage stakeholders such as students, families, staff members, partners, and others in the work of policy advocacy
- Identify channels for advocacy at district, local, state, and national levels
- Represent Breakthrough's policy interests with partner agencies and with decision makers at the district, local, state, and national level
- Report on the outcomes and impact of Breakthrough's policy practice
